



5th/169th Society Convention Hosted by Middlebury Chapter

The Middlebury Chapter hosted the 5th/169th Alpha Delta Phi Society Convention from October 18-21, 2001, at the peak of the Vermont foliage season.

The crisp autumn weather created the perfect setting for a weekend of business and socializing for delegates, alternates, undergraduate members, and graduate members.

The convention weekend opened on Thursday, October 18 with an afternoon meeting of the Society's Board of Governors at the Middlebury Chapter House. After the meeting adjourned, the governors mingled with undergraduate and graduate delegates at the Middlebury Inn and sat down to dinner. Later in the evening, the undergraduates met to formulate the agenda for the next day's undergraduate caucus.

The convention's first two business sessions were held Friday on the Middlebury campus, in a meeting room overlooking the sweeping vista of the Green Mountain National Forest.

Friday's business sessions covered a wide range of reports, including the growth of the Regional Gradu-

ate Organizations, the status of the Fraternity chapters, and the development of a promotional brochure and mission statement to aid Society expansion efforts.

In the afternoon the convention was treated to a slide presentation on the Breadloaf Writers' Conference, held annually at Middlebury's Breadloaf Campus since 1926. Professor David Bain narrated a col-

In Memoriam: Daniel Pearl, S '85

The Alpha Delta Phi Society extends its sympathy and support to the friends and family of *Wall Street Journal* reporter Daniel Pearl.

Pearl, a member of the Stanford Chapter's Class of 1985, was kidnapped and later killed by his captors while covering the war on terrorism in Pakistan this February.

Pearl's fellow Stanford Alpha Deltas remembered him fondly during memorial services held since his death was confirmed by the U.S. State Department.

Stanford University has announced the creation of an endowment fund in Pearl's honor to support communications students. Pearl's friends and family also have announced the creation of a trust fund for his wife and child and a new Daniel Pearl Foundation.

Society in 2000-01 Records 8th Balanced Budget in Nine Years

The Alpha Delta Phi Society finished the 2001 fiscal year (ending June 30, 2001) with a positive cash flow of \$2,475.84. This represents the eighth balanced budget the Society has recorded in the first nine years of its existence.

Keeping the budget balanced, or positive, allows the Society to grow its endowment. While the Society has implemented an endowment reliance policy, the goal is to finish the year with a positive cash flow so the endowment can increase as much as possible each year.

While revenues in FY 2001 were below budget, the Society kept its expenditures below projections (see detailed summary in the next column).

This was also the first year of a new fundraising campaign with the Alpha Delta Phi Foundation (*see story on page 3*).

The budget summary reflects the new financial statement process adopted by the board of governors last year, and ratified by the Middlebury Convention in October 2001. Society Reviews Budget for Fiscal Year 2002

The Society's Board of Governors reviewed the budget extensively prior to the Middlebury Convention. The examination was necessary because of the impending retirement of President Robert G. McKelvey, MID '59, after the convention was over.

McKelvey contributed considerable office and administrative expenses from the Society's founding. The Society needed to adjust its budgeting to reflect the fact that it would need to take on these administrative functions after McKelvey's retirement.

The board of governors decided to increase the number of services it contracted from its headquarters staff at Organization Communications Services, Inc. The board decided that this was the most efficient and cost-effective way to enhance the Society's administrative capability.

In order to pay for these increased services, the Society reviewed all of its budget lines to ensure that it was spending its money wisely. Several budget items were accordingly adjusted downward.

The board also decided to increase its fund appeal goal from \$15,000 to \$18,500 to help pay for these new services. These budget revisions were ratified by the delegates to the Middlebury Convention.

Positive Response to Fund Appeal Necessary For Balanced Budget In FY 2002

As of late April, the Society's cash flow for the current fiscal year was positive by a small amount. Several major expenses, including an undergraduate caucus, board of governors meeting, this *Society Xaipe*, and an allocation for the 2003 Convention must be paid in the final months of the fiscal year.

A positive response to the Society's fund appeal (included in the mailing with this *Society Xaipe*), will determine whether the budget is balanced. As of late April, the Society needed to raise nearly \$10,000 to reach its fund appeal goal for the year. The Society has been able to meet that target in previous years.

¹ The board of governors adopted a policy at its October 16, 1997, meeting to restrict annual reliance on the Society's endowment to 4.5% of the three-year moving average of the endowment's value.

² Approximately \$10,000 was raised by the AΔΦ Foundation from Society members to support charitable purposes. The Foundation allocated \$1,500 for convention educational programming.

³ Contributed expenses covered 65.7% of board of governors expenses and 96.5% of other office expenses.

Convention Delegates Create “Statement of Intent” For New Society Promotional Materials

Undergraduate and graduate delegates were joined by board of governors’ representatives and other interested attendees to create a “statement of intent” for the Alpha Delta Phi Society (*see box at right*).

Graduate Delegate E. Jenny K. Flanagan, MID ’83, one of the organizers of this statement drafting session, explains why it was needed. “These promotional materials that will be sent to organizations and universities expressing interest in hosting a new Alpha Delta Phi Society chapter, or sent to target institutions where we would like expansion to occur.”

Chapters could also use these materials as part of an information packet for prospective members.

These promotional materials are only in the conceptual stage right now, but the board of governors hopes to have something completed later in 2002.

Society Exceeds Fundraising Goals For 2001 Fiscal Year *New Initiative With AΔΦ Foundation Begins*

The Society achieved its fundraising objectives for the fiscal year ending June 30, 2001 despite an increasingly difficult economic environment.

The Society also inaugurated an important new initiative with the Alpha Delta Phi Foundation, reported Robert G. McKelvey, MID ’59, Development Chairman, to the convention delegates at Middlebury.

The Society had a \$15,000 fundraising goal in its budget and raised a total of \$14,100 from members plus \$9,100 in contributed expenses. The contributed expenses came primarily from members of the board of governors.

In addition, McKelvey reported that members were now able to contribute to the Alpha Delta Phi Foundation to support educational and leadership training and programs, and an additional \$10,000 had been contributed last year.

Almost \$4,000 of that amount had been used to support programs and presentations at the Middlebury Convention. These included an illustrated talk on the Bread Loaf Writers Conference, one of the oldest and most prestigious programs in the U.S. literary world, by author David Bain, who has been affiliated with Bread Loaf since 1981.

Gifts to the Foundation are tax deductible and must be \$250 or more for this new program.

The recent economic downturn impacted giving increasingly as the year progressed. The total number of gifts declined from 234 in 2000 to 145 in 2001 and the last 2001 mailing in May generated the lowest response of any Society mailing since its inception in 1992.

McKelvey noted that the fundraising goal for 2002 had been increased from \$15,000 to \$18,500 and he encouraged Society supporters to respond to this appeal so the Society can maintain its programs and support of the chapters in 2002.

The Major Donor Honor Roll was presented to the convention honoring 16 members who had contributed \$500 or more during the year and is reprinted elsewhere in this issue. The Loyalty Honor Roll was also presented honoring 93 members who had contributed to the Society for five consecutive years or more and 44 members who had contributed for all of the Society’s nine years.

“Most organizations,” McKelvey noted, “honor major donors, but for some people a \$50 donation each year is more of a sacrifice than a \$500 donation is for others. This loyalty deserves to be recognized and honored and we are proud to publish this “Loyalty Honor Roll.”

Reports From The Chapters

BOWDOIN CHAPTER

The chapter's graduate organization remains active and will gather together during the Bowdoin's reunion weekend, May 31-June 2. The graduate organization's annual meeting will be held at 9:30 a.m. on Saturday, June 1. BRUNONIAN CHAPTER

The Brunonian Chapter currently has 39 total members. One of the chapter's social rooms has recently been converted into an office with a copier, helping the chapter save money on house advertising. The Brunonian Chapter currently has 14 pledges. Major community service events include the annual Bizarre Bazaar, held May 18. This year's event raised \$6,500 for Providence Summerbridge, a local charity that provides summer courses to underprivileged students. The Bizarre Bazaar is Brown's largest charity fundraiser.

COLUMBIA CHAPTER

The Columbia Chapter currently has 40 members. Nine new members were initiated into the Alpha Delta Phi on May 3. The chapter hosted the most recent Board of Governors meeting May 3-4. The chapter house is currently undergoing some renovations.

MIDDLEBURY CHAPTER

The Middlebury Chapter currently has 82 members, with strong underclass representation. Pledging took place in the fall, culminating with the initiation of 28 sophomores. Twenty-seven seniors will graduate this May. The Middlebury Chapter hosted the Society's fifth convention from October 18-21, 2002. Convention business sessions were held on the Middlebury campus. The Friday night dinner was held at the chapter house and the Saturday banquet was hosted by the Dog Team Tavern.

MIDDLETOWN CHAPTER

The Middletown Chapter currently has 56 members. The chapter initiated 10 new members during the fall semester. The addition of a new egress to the Greene Room has more than doubled the room's capacity. The chapter will participate in Wesleyan's commencement and reunion activities the weekend of May 23-26.

STANFORD CHAPTER

The Stanford Chapter had a successful recent rush and initiation, adding eight new members and bringing the total chapter membership to 15. The chapter is currently unhoused on Stanford's campus and is seeking a permanent home. Stanford is holding literary nights weekly on Thursdays, bringing about 20 people to the chapter each week. The undergraduates hold weekly social events with graduate Alpha Deltas on Fridays.

Join The Society's Regional Graduate Associations

The Society's regional graduate association in the greater Boston area has completed another active year. The Boston group has had ski trips, organized trips to events at the nearby Society chapters, and held social gatherings in and around Boston. The group has established a web page (boston.adps.org), and Jennifer Greenwood, BRN '98, sends out regular e-mails to inform Bostonian Alpha Deltas of upcoming events. You can join that update list by writing to Greenwood at adps-boston@yahoo.com.

The Middlebury Convention's graduate caucus discussed the importance of these regional graduate associations. The Alpha Delta Phi Society is a lifetime membership, and these organizations can help keep graduate members in touch with other Alpha Deltas. They are also a wonderful opportunity to meet members from other chapters.

The board of governors has approved an initial allocation of \$250 for each graduate organization to help with initial mailings and other activities.

Small groups in New York City and Washington, D.C. have also met in the last year. The board of governors hopes that these regions can establish active regional groups in the near future.

The Society also plans to establish a San Francisco Bay area regional group in the next few months. Stanford Chapter graduate members are working with other Alpha Delt graduate members in the area to plan an opening social event.

lection of rare slides highlighting the timeline of this renowned conference, first popularized by Robert Frost and including such luminary Alpha Delts as Stephen Vincent Benét, Y '19.

Our second guest speaker for the afternoon was Andrew Burton, K '00, who spoke to the convention about recent strides taken to improve the membership database for the Society. Andrew explained that this will centralize membership information, improving the accuracy of mailing lists and allowing individuals to update their information via the internet.

At the close of the day's business sessions, undergraduates and graduate members held their respective caucuses. In the undergraduate caucus, the issues discussed included the Society Pledge Manual, possible policies for the wearing of the Badge, and the inclusion of undergraduates on the Society Internet Committee.

The undergraduates also held elections for a new Undergraduate Governor, resulting in a persistent tie that led to the election of two members who will share the position. Nicholas Foeger, BRN '03, and James Pesek, MID '04, will work with fellow Undergraduate Governor Jessica Resnick-Ault, BRN '02.

The graduate caucus addressed the dilemma of creating a pan-chapter regional organization in areas where undergraduate chapters already exist, such as Manhattan and the San Francisco Bay Area. Members from the

local Chapter Graduate Organizations and those spearheading the Regional Graduate Organizations agreed to continue the dialogue to determine the best solution for each area.

Among other items of business, the convention delegates voted to alter the requirements for the Society Order of the Sword and Spear and add a monetary prize for the winner's chapter; to mandate undergraduate positions on the Society Internet Committee, and to complete the Society-wide pledge manual for use in the fall of 2002. The convention also approved all nominations for governors and executive council members.

The convention banquet was held on Saturday night at the 1796 House and Inn, featuring a reflective speech by one of the Middlebury Chapter's founding members, Elizabeth Seeley, MDBY '96.

The traditional toasts were given by banquet attendees, and Awards Committee Chair Jennifer Reid, BRN '92, presented the first Star and Crescent Award for Distinguished Service to outgoing President Robert McKelvey, MID '59.

Incoming President Charles Gross, BRN '72, reflected on Bob's instrumental role in the creation of the Society and his profound contributions throughout the past ten years. After a song-filled ride back to the Middlebury Inn, many Alpha Delts adjourned to the chapter house and socialized long into the night.

New Officers Elected at Middlebury Convention

After serving for ten years as the Society's founding President, Robert G. McKelvey, MID '59, stepped down at the Middlebury Convention in October 2001.

Newly elected officers are President Charles E. Gross, Jr., BRN '72, Vice President and Treasurer Craig C. Cheslog, BDN '93, and Secretary Jennifer Greenwood, BRN '98. All have a long history of service to the Alpha Delta Phi Society.

Gross has been an officer of the Brunonian Chapter's alumni association for many years and has served on the Society's Board of Governors since 1992.

An active Bowdoin graduate, Cheslog has also served on Society's Board for many years, in addition to terms as Secretary, Treasurer, and editor of our newsletter, *Society Xaipe*.

A recent Brown graduate, Greenwood served as President of her chapter and has been instrumental in building an active alumni network in the Boston area.

Said President Gross, "Under Bob McKelvey's leadership, the Society made significant progress in a relatively short period of time, and we are all grateful

for everything he has done to get the Society off to a good start. With the continued support of our graduate members, we look forward to making more progress in the years ahead, including exploring expansion opportunities on additional campuses."
