New Middlebury Chapter House Dedicated

In October of 1993, I was barely a graduate of the Brunonian Chapter when I was dispatched to investigate a request, initiated by a group of undergraduates at Middlebury College in Middlebury, Vt., to form a Chapter of the Alpha Delta Phi Society. The group of 24, led by Elizabeth Seeley, MID/MDBY '96, was interested in forming a coeducational group as part of the Middlebury College's social house system.

On short notice and in the middle of midterm exams, 23 of the 24 undergraduates met with me on a chilly autumn night. The spirit was considerably warmer, and within a month, the Society's Board of Governors granted affiliate status to the Middlebury group.

The story moves forward to August 1995 in Providence, R.I., and the Second/163rd Alpha Delta Phi Society Convention hosted by the Brunonian Chapter. Thanks to the hard work of Seeley and her cohorts, the Middlebury Affiliate became the Middlebury Chapter at

the Brunonian Convention.

After a few delays, the Middlebury Chapter finally moved into its new (College-provided) Chapter House at the start of the spring 1998 semester. To celebrate, the Society's Board of Governors and delegates from each (continued on page 4)

Bowdoin Hosts Third/165th Society Convention

The Third Convention of the Alpha Delta Phi Society, in the 165th year of the Alpha Delta Phi, was hosted by the Bowdoin Chapter on the campus of Bowdoin College from October 17-19, 1997. It was the first Society Convention hosted by the Bowdoin Chapter, although Bowdoin had hosted Alpha Delta Phi Conventions in 1906, 1929, and 1941.

The Bowdoin Chapter organized an excellent weekend under the guidance of Honorary Convention Chairperson Nessa Burns Reifsnyder, BDN '86, Undergraduate Convention Chairperson Thomas M. Clark, BDN '99, and Graduate Convention Chairperson Craig Cheslog, BDN '93.

Over 60 Alpha Delts joined graduates and undergraduate delegates and alternates from each of the chapters for the convention sessions, leadership seminars, and social activities. The Society's Board of Governors also held meetings at the chapter house on Thursday prior to the start of the Convention, and on Sunday following its adjournment.

Board of Governors Meet at Middlebury

The Society's Board of Governors met at the Middlebury Chapter on April 3-5, 1998, in conjunction with the undergraduate caucus, the dedication of the new Middlebury Chapter House, and the formal presentation of the charter to the Middlebury Chapter.

The board reviewed the Society Constitution approved at the Bowdoin Convention in October 1997 and voted unanimously to send it to the chapters and graduate organizations for ratification by June 30.

The board reviewed the Society's financial statements for 1997-98, and noted that a strong increase in initiations had put the Society in a good position to achieve its sixth consecutive balanced budget. Society Treasurer David Ehrlich, S'84, reported that the Society's portfolio was performing satisfactorily and that the 4.5 percent reliance upon the endowment might not be needed this year. Ehrlich noted, however, that the Fifth Anniversary Fund Drive, with an expanded goal of \$25,000, needed to make major strides before June 30 to achieve its objective.

The graduate organization of the Middlebury Chapter met with the board and sought recognition as an official graduate organization. The board granted this recognition. The board also authorized the creation of an intern position at the headquarters for the summer of 1998.

The Bowdoin Chapter reported that there had been no positive change in its situation with the college. The board authorized a committee to work with the chapter and graduate organization to preserve its assets and heritage until a change in college policy could be negotiated.

Tim Smith, BRN '93, chair of the expansion committee, reported on several potential new sites for Society chapters. The board agreed to continue examining these options.

The board voted to send a \$2,000 contribution to the Alpha Delta Phi Fraternity to help offset the significant legal expenses incurred by the Fraternity while defending the Alpha Delta Phi trademark against the former Northwestern Chapter. The fraternity's legal action helped to protect the Alpha Delta Phi name and the Society's right to that name. The contribution was authorized by a vote of the Second/163rd Convention.

The board ratified the petition of the Columbia Chapter to host the next Society Convention from October 17-19, 1999, in New York City.

The next Society Board of Governors meeting will also be held at the Columbia Chapter, from October 2-4, 1998.

Undergraduate Caucus Report

The Spring 1998 Undergraduate Caucus was hosted by the Middlebury Chapter in April 1998 in conjunction with the charter installation ceremony. The undergraduates from each of the Society chapters meet at least once a semester to discuss issues that they share and to help renew their ties to each other as Alpha Delts.

The caucus opened with nominations for an undergraduate governor to replace Erica Sang, BDN '98, whose term had expired. Thomas M. Clark, BDN '99, won the majority of the votes for a one-year term as Undergraduate Governor.

At the Bowdoin Convention, it was clear that there were some differences in the way members of each chapter wore their Society badges. A working group was organized by the Society's Board of Governors to investigate the issue and then report to the next Convention.

The members of the undergraduate caucus discussed the practices of wearing the badge at length. Chapter practice at the Columbia and Brown Chapters is to hide the pins, the Stanford and Middlebury Chapters leave it to the discretion of the individual, and the Bowdoin and Middletown Chapters wear the badges openly. Since it did not seem possible for everyone to agree on the issue, it was decided that each chapter should follow its own rules at home and abide by the rules of the host chapter when visiting.

The caucus then discussed rush, examining what each chapter does and what regulations each college or university administration has made on rush activity.

One of the members of the Middletown Chapter brought up the possibility of starting an undergraduate fundraiser by selling Alpha Delta Phi Society merchandise. Most people agreed that the idea was a good one, and that following a more specific plan of action we could begin work on the project at the next caucus.

Report from the Chapters

The **Bowdoin Chapter** hosted the Society's third Convention in October. The undergraduates have organized the Geoff Stanwood Memorial Literary Competition for the second year, and they look forward this spring to awarding the Franklin Delano Roosevelt Cup for its 58th time. The chapter's literary program continues, with professor nights and other events. Graduates of the chapter will once again meet during Bowdoin's reunion weekend (May 29-31).

The **Brunonian Chapter** initiated seventeen new members in November 1997. Many of these new initiates have already taking on leadership roles in the chapter, resulting in another extremely successful rush as 26 people pledged this spring. Numerous events have been hosted this semester, including a highly successful Swing Dance. The chapter recently hosted its annual charity auction, the Bizzare Bazaar, which took place on April 16th and raised nearly \$4,000.

Over the winter break, the **Columbia Chapter** house received some long-needed renovation and everyone is excited about the house's new look. The dining room floor was completely redone, while the rest of the flooring throughout the house was sanded and refinished. Lit Nights are especially popular now as members are apt to be sitting in the new furniture by the fire. A successful

After its rush, the **Middletown Chapter** pledged a class of eight enthusiastic individuals earlier this spring. The Chapter initiated 14 people during the fall semester. Also last fall, the chapter donated money to help save the Wesleyan Film Series. At this year's June Weekend (May 29 to 31), Middletown will be celebrating the 25th anniversary of coeducation. It promises to be a memorable event.

The **Middlebury Chapter** continues to grow. This past fall, the chapter initiated 33 new men and women into the Alpha Delta Phi Society. In January 1998, the members of the Middlebury Chapter moved into a new chapter house—which has received rave reviews. Members from all of the Society's Chapters travelled to Middlebury for a charter installation ceremony the weekend of April 3-5.

The **Stanford Chapter** initiated nine new members in late November 1997. They are planning a community service project with Habitat for Humanity for this winter, as well as the publication of their literary journal, Sweet Green. of the Society's chapters went to Middlebury the weekend of April 3-5 for board business meetings, the undergraduate caucus, and ceremonial events.

The weekend's events were originally scheduled for January 1998, but were postponed due to the ice storm that paralyzed much of New York, New England, and Canada. The installation ceremonies for the chapter began with Society President Robert McKelvey's, MID '59, discussing the Society and the entitlements that come with membership in the Society—including participation in the Literary Competition and Seward Scholarship program, access to the resources of the Foundation for educational and literary activities, fellowship with other chapters, and linkage to the traditions of the Alpha Delta Phi.

Following McKelvey's remarks, each Society Chapter offered gifts to the Middlebury Chapter to warm their new home and imprint it indelibly with the spirit of "The Phi." Leading the chapter roll call, the Bowdoin Chapter fielded a delegation of six, led by Chapter President Thomas M. Clark, BDN '99. The Bowdoin Chapter offered a gift of several pieces of Alpha Delta Phi china and a copy of the 1966 Alpha Delta Phi Catalogue, which includes the history of every Alpha Delt chapter.

The Columbia Chapter, whose four-member team was led by Chapter President Dylan Hightower, COL '99, gave two hand-wrought items. The first was a stained-glass rendering of the "bright star and silvery crescent of our A. D. Phi." The second was reproduction of the badge which adorns the facade of the Columbia Chapter house at 526 West 114th Street in New York City.

The sizable contingent of nine Alpha Delts from the Middletown Chapter, which was the sponsor chapter of the Middlebury Affiliate, gave two items to the new chapter. The first was a pencil drawing of the Middletown Chapter House at 185 High Street, matted in green with a notation to commemorate the evening's events. The undergraduates, led by Colleen Ryan, MID '00, noted that The Alpha Delta Phi was an organization that often rewarded virtue, but that everyone needs a "little vice." The gift she presented was a small vice of the woodworking variety, decked in the green and white.

The Stanford Chapter fielded a crew of five intrepid travelers, led by Society Governors David Ehrlich, S'84, and Simona Agnolucci, S'98, and Chapter President Shivani Ganguly, S'99. The Chapter presented a handblown multicolored bottle, symbolizing the many parts (continued on page 5)

that make up The Alpha Delta Phi. They also gave two books of poetry, inscribed for the occasion, to become the first two volumes of the Middlebury Chapter Library.

Several other gifts were given to the new chapter, including a pair of cobalt-blue glass bottles with complementary silver crescent and star stoppers. A bronze candlestick and a pair of brass candlesticks, each featuring the star and crescent motif, were also presented. Chapter President Jed Harris, MDBY '99, noted with amusement that a recent power outage had left the Middlebury undergraduates scrambling for alternative light sources, making the candlesticks welcome additions to the house.

Society Executive Director William Millard, ILL'80, representing the Alpha Delta Phi Foundation, gave Middlebury Chapter President Harris a check in the amount of \$1,000 to the Middlebury College Library Book Purchase Fund on behalf of the Middlebury Chapter of the Society. Harris reports that the Middlebury College External Affairs office, through which the College accepts such gifts, was delighted with the unexpected windfall for the Library.

A pair of complementary gifts came from the Brunonian Chapter and the Society Board of Governors.

Six Brunonians, led by Graduate Association President Charles Gross, BRN '72, and Undergraduate President Jason Rantanen, BRN '99, unveiled a newly-constructed maple pedestal approximately four feet in height and of suitable dimensions to support the penultimate gift from the Board of Governors.

President McKelvey noted the emptiness of the stand on which he had been leaning throughout the evening's presentations, and directed Jed Harris to the remaining box. Safely ensconced inside was a new Brothers-In-Arms Statue cast under the direction of Joe Fedison, a graduate of the Fraternity's Rochester Chapter.

The culmination of its work and official recognition of its new status came when this writer had the honor of presenting, on behalf of the Board of Governors, the first Charter issued to a new chapter in The Alpha Delta Phi Society. Harris, the Middlebury Chapter president, reports that the Charter, Mike and Ike, and all the gifts have found a new home in the Chapter's Library, where they have already sparked the interest of recent visitors.

The spirit of Samuel Eells has taken up residence at a new academic institution. May his memory long live there, warmly welcomed by the fire of the Middlebury Chapter.

Three Views of the Middlebury Chapter House



The exterior of the Middlebury chapter house is faced in gray wood shingles, and stone, although the building structure is of concrete. The central feature of the house is the living room with its peaked cathedral ceiling. Wooden trusses lead the eye to the ridgeline, some 30 feet over the tile floor. A second-floor balcony overlooks the living room below. A library is located off the north side of the living room. Both the living room and a smaller lounge on the second floor have fireplaces. Thirty undergraduates live in 14 single and eight double rooms on the two main floors. The basement is one large room, and includes a third fireplace. All three floors have large windows overlooking a small valley to the west and the Adirondacks beyond.—TS





Fifth Anniversary Fund Drive Is Key to Successful Financial Year

Thanks to a surge in new initiates, the Alpha Delta Phi Society appears to be headed towards another balanced budget despite a slow start to the Fifth Anniversary Capital Campaign.

Society Treasurer David Ehrlich, S '84, reported to the Board of Governors at their April meeting that the results through three quarters (July 1 to April 1) show most chapters and graduate organizations have paid regular fees and initiation fees in full. In addition, initiations are running well ahead of last year and could reach a record number before the end of the year.

Ehrlich noted, however, that the Fifth Anniversary Fund Drive, which had set a target of \$25,000 (5x5), was behind projections with \$10,000 raised to date.

It should be remembered, however, that the spring *Society Xaipe* and fundraising letter have usually produced strong results, so the Board of Governors remains confident that this special goal will be achieved. The

Board also agreed that the extra funds, if raised, would be reserved for the next expansion project.

The Board received the first report from the investment committee following the hiring of a manager for the Society's small endowment portfolio at the Bowdoin Convention in October 1997. The Society's investment strategy calls for 50 percent invested for safety and income in bonds with the other 50 percent invested in equities for growth. Investments were made during December and January which proved to be timely. Results to date are ahead of the appropriate market averages.

The Board's policy is to allocate 4.5 percent of the 12-quarter moving average of the endowment fund to be used, if necessary, in support of each year's annual budget. It is hoped that fund drive results will allow the Society to achieve a surplus each year so that this endowment reliance can be added back to grow the endowment for future uses.

David Ehrlich is the Society's Treasurer.

The Convention's delegates debated and then voted to send a new Society Constitution to the chapters for ratification. Those in attendance heard a report on the Alpha Delta Phi Foundation and established an awards program for the Society. The Convention also heard reports from each of the chapters.

The undergraduate caucus discussed many issues including rush ideas, a reorganization of the pledge manual, and a chapter communications program. The undergraduate caucus also elected Simona Agnolucci, S '98, and Jessica Perkins, MDBY '98, to serve as undergraduate representatives to the Society's Board of Governors.

One of the highlights of the weekend was a scheduled tour of the Joshua Lawrence Chamberlain Museum, which is located adjacent to the Bowdoin Chapter House. Chamberlain is perhaps the most famous Bowdoin Alpha Delt, having earned the Congressional Medal of Honor for his heroics on Little Round Top at Gettysburg during the Civil War. Chamberlain later also served as president of Bowdoin College and governor of Maine.

Following the final convention session, a banquet was held at Brunswick's Captain Daniel Stone Inn. Society Governor A. Paul Neshamkin, COL '63, continued the Alpha Delt tradition of raising toasts after a short explanation of their history and each chapter introduced its members to all in attendance. Following the dinner,

Society President Robert McKelvey, MID '59, offered some brief remarks about the Convention's achievements, and Reifsnyder, the Honorary Convention Chairperson and Bowdoin Graduate Association President, thanked everyone for their support and for attending the Convention.

The Columbia Chapter has agreed to host the Fourth Alpha Delta Phi Society Convention in 1999. More information about the Columbia Convention will be made available in future *Society Xaipes*.

Bowdoin College to Phase Out Greek System

Bowdoin College is currently in the process of phasing out its Greek system in order to initiate a "college house" system of student life. As a result, Bowdoin's Greek organizations, including the Alpha Delta Phi Society Chapter there, have been barred from rushing or initiating any new members since the spring of 1997. All of the houses will be closed in May 2000.

The decision, made unanimously by the Bowdoin Trustees, was based on a set of recommendations made by a Commission on Residential Life. The Commission was asked to examine all aspects of residential life at Bowdoin and then make recommendations on how student life can be improved.

When it became clear that Bowdoin President Robert H. Edwards was going to seek the abolition of Bowdoin's Greek system, the Alpha Delta Phi Society began to coordinate with the Bowdoin Chapter on a course of action.

The original goal of these efforts was to lobby the Commission to reform—and not abolish—the Greek system. The first stage of this assistance began almost immediately with a series of conversations between leaders of the Society and the Bowdoin Chapter. These initial conversations were strategy sessions, including suggestions about a course of action and how best to frame the issues that would soon be facing the chapter.

Perhaps the most important suggestion was "to avoid defending the indefensible." Initial discussions among Bowdoin graduates indicated a desire to defend the entire Bowdoin Greek system. However, a series of incidents (including one that resulted in the death of a University of Maine undergraduate at an illegal party) made such a defense impossible.

Discussions continued throughout the summer and fall between members of the Society Board of Governors and the Bowdoin Chapter's leadership. The Society's Board of Governors were kept updated about the developments at Bowdoin and were solicited for input. The Society also financed a letter to all Bowdoin Chapter Alpha Delta Phi Society graduates urging them to write to the Commission and to attend at least one of the several regional meetings held by the Commission to seek input from its graduates.

Despite these and other efforts on behalf of the Bowdoin Chapter, the Commission made its recommendation to phase out the Greek system. As a result, the Bowdoin Chapter faces several challenges.

The first is keeping the chapter house open until all of its current members graduate in May 2000. It was

decided at the last annual meeting of the Bowdoin Chapter that everything possible needed to be done to keep the chapter house open until then. Of course, as each class graduates between now and the phase-out date, this becomes increasingly difficult as there will be fewer members to reside in the chapter house.

The second immediate challenge is the disposition of the chapter house. Bowdoin Alpha Delts have discussed this problem extensively since the Commission's decision was made. At this time, the Bowdoin Chapter is trying to negotiate a lease agreement with the Bowdoin administration. In case these negotiations fail, the chapter is also examining leasing to a non-profit consortium, or selling to a third party.

A subcommittee of the Bowdoin Chapter's leaders have started the lease negotiations. It is hoped that a concrete plan of action, based on these discussions, can be brought to the Bowdoin Chapter's graduate and undergraduate members at its May 30 annual meeting.

The Society's Board of Governors will continue to support the Bowdoin Chapter during these negotiations and into the future. In the history of The Alpha Delta Phi, seven chapters have been closed and later reopened when circumstances and college policies have changed. In fact, the Bowdoin Chapter itself was closed for a period of four years during the early 1970s before reopening.

The Alpha Delta Phi Society will also continue to work in all appropriate ways to ensure that college students have the opportunity to join and associate with others in Greek organizations. The Society, through its membership in the National Capital Interfraternity Forum, is tracking possible legislation designed to ensure that college students rights are protected.

Most importantly, all Bowdoin Chapter members are urged by the Society's Board of Governors to keep their ties to the Society active despite the Bowdoin administration's decision to close the Greek system. In addition to the importance of keeping the ties between Bowdoin Alpha Delts and all Alpha Delts strong, there will be opportunities to help with projects like expansion, regional graduate chapters, and the anticipated chance to reopen the Bowdoin Chapter sometime in the future.

Society Sends New Constitution to Chapters

In October 1997, the Third/165th Convention of the Alpha Delta Phi Society approved a Constitution for the Society, which is now being submitted to chapters and graduate organizations for ratification. If approved as expected, the Constitution will be the fundamental law governing the Society's functions into the 21st century.

Since its founding in 1992, the Society has been operating under the existing Fraternity Constitution. However, that document still formally restricts membership to males, and contains other features not applicable to the Society. Society Secretary Craig Cheslog, BDN '93, has sent a copy of the proposed Society Constitution to each chapter and graduate organization for ratification. If 4/5 of the chapters and alumni associations approve the document by a 2/3 vote, the Constitution will be binding.

The quest for a new Society Constitution began in earnest last spring, when Governor Pamela Coukos, BRN '90, convened a committee to create a new draft. Originally, the main purpose of rewriting the constitution was to incorporate gender-neutral language. But after a closer review, other changes seemed to be in order.

For example, the Fraternity Constitution has a regional structure, something that is inappropriate for an organization of the current size and composition of the Society. Some of the other structural changes included adapting mechanisms regarding the number and selection of the Board of Governors to fit Society practice, and incorporating language to allow either biannual or annual Conventions. The drafters substituted genderneutral terms throughout, and the male restriction on membership was, of course, deleted. In large measure, however, the Society Constitution retains most of the language and spirit of its Fraternity counterpart.

"This Constitution strikes the right balance between continuing the shared legacy of The Alpha Delta Phi Constitution and the particular needs of the Society," said Society President Robert McKelvey, MID '59. "I am excited to have it approved unanimously at Convention, and I expect that ratification will be speedy and unanimous."

Many members of the Society's Board of Governors played a role in this effort. Mary Melchior, MID '84 participated in initial drafting sessions. Tim Smith, BRN '92, and Cheslog made particularly significant contributions during and after the Convention, as delegates refined the Board's draft language and then adopted the Constitution unanimously. Paul Neshamkin, COL '64, served as a special advisor throughout the drafting process, and McKelvey reviewed drafts and assisted in advising the committee during the Constitution's development.

Since the Board of Governors meeting scheduled for January had to be moved to April, there has been a slight delay between the Convention approval and the submission for ratification. A full Board review of the draft was necessary to ensure that all of the changes made at Convention were correctly documented before it was sent out for ratification and to make a final check for any technical errors. Board members have been assigned to each chapter and alumni association to serve as contacts during the ratification process. The Board hopes that ratification will be complete by June 30.
