Freshly-Minted Capital Chapter Hosts Society's 2017 Convention & Leadership Training Conference

Siblings from around the country assembled this past March for the Alpha Delta Phi Society's 17th Annual Convention and Leadership Training Conference in Rosslyn, Virginia, just outside of Washington D.C.

And as always, the weekend was an exciting blend of business, awards, and antics.



One of the biggest stars of the weekend was the Capital Chapter. The Capital membership successfully hosted their first—ever Convention, applied for and received chapter status a mere three years after their founding, and enjoyed it all while operating under the full name Alpha Delta Phi Society, the first Convention during which they could do so (see Society President Kristen Soule's report on page 2 for more on this development).

This year's Convention also put the fun back in fundraising. A handful of donation challenges encouraged a total of \$22,000 to be raised on behalf of the Society, including a whopping 84 contributions from young donors. Governors Liam Carpenter–Urquhart (Brunonian 2019), David "Toasted" Clodfelter (Bowdoin 1989), Dena Schwartz (Penn 2013), and Kristen Soule (Brunonian 1999) volunteered to take a cream pie to the face and raffle off the pie–ing privilege to a lucky donor.

President's Report: New Agreement Launches New Era in the Society-Fraternity Relationship

I am thrilled to report this news from this year's Fraternity Convention in Minneapolis, Minnesota: the Committee on Fraternity–Society Relations has negotiated a new agreement, replacing the 1992 Fraternity–Society Agreement.

This joint committee spent years navigating the rocky shoals between our two organizations. We hit obstacles. We were warned it couldn't be done. *Nevertheless, we persisted.*

As a result, after 25 years existing under an agreement that was in many ways lopsided, this is a monumental step forward in relations between the two organizations, with updates that simplify our interactions and treat both of us as equally respected parties.

The most impactful and exciting change is that there are no longer any geographic restrictions on where we may use the name "Alpha Delta Phi Society." This change allows us to use our identity at all of our chapters and affiliates! Further, the complicated set of rules that had governed our expansion efforts have been reduced to a concise, logical standard.

This is a transformational moment in the history of the Alpha Delta Phi Society. From the Brown Compromise in 1973 which allowed women to be initiated as "local members" through the many negotiations of this agreement, there has been a long and varied history of an imbalance of power between the Fraternity and Society.

This agreement establishes a new foundation where both organizations can share our common roots and history, traditions and goals, and move forward in a relationship of cooperation and respect.

We finally have the parity, respect, and recognition we deserve, and it is up to us now to continue to thrive and grow.

Our total number of undergraduate members has been steadily increasing for the past THREE years. Our *Page 2*

Development team once again broke the previous records for AMOUNT of funds raised during the 2016 matching challenge, and also for the NUMBER of young donors!

Over the past year, as a Society, we've been looking inward in many ways, for opportunities to improve.

We took a more cautious approach to expansion, and focused more of our energy and resources on our existing chapters and affiliates. Having two graduate chapters, five undergraduate chapters, and five affiliates at the time, it was the right time to focus on strengthening from within. One of those affiliates applied for a charter, ready to make that milestone transition, and the 2017 Convention ratified the Charter of the Capital Chapter!

Meanwhile, our expansion committee bent their collective thought toward improving strategy and procedures to streamline the addition of new affiliates in the future.

And what began as an offhand silly promise from Jim Sabo on a board call ("I'll shave my head if we get this many new donors") culminated in a heated auction between banquet attendees for the right to shave Sabo's head themselves. This year's Sword and Spear winner Alex Moehring (Binghamton 2016) narrowly outbid Jenny Flanagan (Middletown 1983) for that prize.

Convention business was once again dominated by the Open Space format. First introduced in 2013, the orchestration of many conversation spaces at once proved a successful way to cover as many subjects and engage as many members as possible.

Convention attendees facilitated over 40 discussions through the weekend on topics like grant writing, political diversity, photography basics, and the philosophy of memes. Delegates of the Convention also passed a resolution to reign in spending on future Convention weekends, and a constitutional amendment was introduced to remove ableist language from the Society's governing documents.

New this year, the Convention hosted a training session by Jennifer Dorsey from Uplift: Online Communities Against Sexual Violence. Jen shared her expertise on consent, healthy relationships, and power dynamics, and siblings joined the conversation with their questions and perspectives. The training was followed by a talkback—style open session facilitated by Uplift team member Christine Chapman. Uplift's well—received presentation corresponded with the kickoff of a director—led initiative to increase dialogue about member safety, as well as the release of a new online incident reporting system.

Society Order of the Sword and Spear
